E-DEED WEEKLY PRIZE DRAW PROMOTIONAL COMPETITION

TERMS AND CONDITIONS (RULES)

Last Updated: July 2026

1. Introduction

- 1.1. This promotional competition ("Competition") is organised and run by **E-DEED (Pty) Ltd** (Registration Number: **2024/165407/07**), including its affiliates, partners, and subsidiaries (collectively referred to as the "Promoter").
- 1.2. By entering this Competition, all participants and winners agree to be bound by these terms and conditions, which will be interpreted by the Promoter in its sole discretion.

2. Eligibility

- 2.1. The Competition is open to all permanent residents and citizens of South Africa who are **18 years** or older at the time of entry.
- 2.2. In line with Section 36(3) of the Consumer Protection Act No. 68 of 2008 (CPA), the Competition is **not** open to:
 - Any director, member, partner, employee, agent, or consultant of the Promoter.
 - Any supplier of goods or services in connection with this Competition.
 - The immediate family members (spouse, life partner, parent, child, brother, or sister) of any of the persons listed above.

3. Competition Period

- 3.1. The Competition commences on **9 July 2026** and runs on a recurring weekly cycle until terminated by the Promoter upon reasonable prior notice.
- 3.2. Each weekly cycle begins every Monday at 00:01 and closes on the following Sunday at 23:59 ("Weekly Cycle"). Entries received outside of these hours will not be counted for that specific week's draw.

4. How to Enter

- 4.1. To successfully enter the weekly draw, participants must:
 - **Step 1:** Successfully complete the survey and sign up for an **E-DEED** account via <https://e-deed.com>.

- **Step 2:** Utilise the service during that specific Weekly Cycle by **completing the Wealth Certificate journey and receiving a formally issued E-DEED Wealth Certificate.**

4.2. There are no additional entry fees, subscription costs, or premium-rated SMS charges required to participate in this Competition beyond the standard market costs of utilising the service itself.

5. The Prize

- 5.1. The prize for each weekly draw consists of: **Samsung Galaxy A37 5G 256GB device valued at R8,000** (“the Prize”).
- 5.2. The Prize is non-transferable, non-negotiable, and cannot be exchanged or redeemed for cash or any other item.

- 6.1. One (1) winner will be selected each week via an automated, audited random draw system from all eligible entries received during that specific Weekly Cycle.
- 6.2. The draw will take place every **Tuesday** following the completed cycle.
- 6.3. Winners will be notified via **email** within **2 (two) business days** of the draw using the contact details provided during their account sign-up.
- 6.4. The Promoter will make **3 (three)** attempts to contact the winner over a period of **7 (seven)** business days. If the winner cannot be reached, fails to provide validation information, or declines the prize, they will forfeit the prize, and the Promoter will conduct a random redraw for a backup winner.

7. Marketing and Image Rights

- 7.1. In compliance with South African Consumer Law, the winner has the right to **decline** any publication of their name, surname, images, or participation in any marketing or promotional activities.
- 7.2. Should the winner give explicit, written consent to be featured, the Promoter may publish their name and image on **our official website and social media channels** at no fee or compensation to the winner.

8. Protection of Personal Information (POPIA)

- 8.1. By entering this Competition, participants acknowledge that their personal data will be collected and processed by the Promoter solely for the purpose of administering this Competition (including winner verification and prize delivery).
- 8.2. All personal information will be processed securely and in strict compliance with the Protection of Personal Information Act No. 4 of 2013 (POPIA) and the Promoter’s Privacy Policy available at <https://www.e-deed.co.za>.

9. General Limitations of Liability

- 9.1. The Promoter, its directors, employees, and agents accept no responsibility and will not be liable for any loss, damage, injury, or disappointment suffered by any participant resulting from entering the Competition or accepting the Prize, except where such liability cannot be excluded by South African law.
- 9.2. The Promoter is not responsible for any technical failures, network delays, or incomplete entries caused by internet connectivity or platform outages.
- 9.3. The Promoter's decision regarding any aspect of the Competition is final and binding, and no correspondence or disputes will be entered into.

10. Audit and Regulatory Compliance

- 10.1. This Competition is conducted in accordance with Section 36 of the Consumer Protection Act No. 68 of 2008.
